

AMENDED NOTICE OF SUBCONTRACTOR'S CLAIM AND H.LINOIS MECHANICS LIEN CLAIM

The Claimant, MTH ENTERPRISES, LLC d/b/a MTH INDUSTRIES, an Illinois limited liability company ("Claimant"), with an address at One MTH Plaza, Hillside, Cook County, Illinois, hereby files its amended notice of subcontractor's claim and Illinois mechanics lien against CLUNE CONSTRUCTION COMPANY ("Contractor", for a project at Holy Cross Hospital, 2701 W. 68th Street, Chicago, Cook County, Illinois (the "Property"), SINAI HEALTH SYSTEM a/k/a SINAI HOSPITAL SYSTEM AND HOLY CROSS HOSPITAL ("Owner"), owner of the Property, and any persons claiming to be interested in the Property, and states.

- 1. That on March 14, 2017, Claimant made a contract with Contractor to furnish glass and glazing for the 1st floor Crisis Stabilization Unit, all related materials and labor, for the sum of \$255,755.00 (the "Contract").
- 2. That on October 18, 2017, Claimant filed its Notice of Subcontractors Claim and Illinois Mechanic's Lien Claim dated October 17, 2017 against Owner in the appoint of **Two Hundred Forty-Seven Thousand Five Hundred Ninety-Five and 00/100 Dollars** (5217,895.00) on the Property, which claim was recorded in the office of the Cook County Recorder on October 18, 2017 as Document No. 1729146054 (the "Lien").
- 3. This Notice hereby amends the Lien to reflect that, as of October 18, 2017 there was due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of One Hundred Ninety Thousand Five Hundred Thirty and 00/100 Dollars (\$190,530.00). Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$190,530.00 plus attorney fees and costs.
- 4. The last date on which materials or labor were provided to the Property was July 20, 2017, however Claimant's work at the Property is incomplete to date. Claimant expects to fulfill certain labor and material obligations to the Property in the amount of \$65,225.00, upon which it retains its right to claim a lien pursuant to the Illinois Mechanics Lien Act, in the future. The Contract remains in full force and effect.
