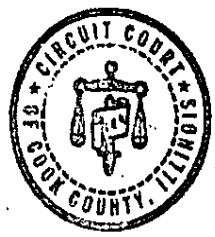

STATEMENT OF INTEREST ("LIEN CLAIM")


