

#### ORDER GRANTING AMENDED MOTION TO ADJUDICATE CHARGING LIEN AND AWARD IN PERSONAM JUDGMENT AGAINST THE LITIGANTS

THIS CAUSE came to be heard before this Court on January 29, 2015, on Staack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A.'s Amended Motion to Adjudicate Charging Lien and Award In Personam Judgment Against the Litigants, and the Court, having reviewed the file and heard argument of counsel, and being otherwise fully advised in the pramises:

- All of the elements necessary to impose a charging lien have been met, including timely notice. In order to give timely notice of a charging lien, an attorney should either tile a Notice of Lien or otherwise pursue the lien in the original action. Zimmerman v. Livnat, 507 So. 24 U. 205. 1206 (Fla. 4th DCA 1987) (citing Sinclair, 428 So.2d 1383 (Fla. 1983)); see also, Daniel Mones, P.A. v. Smith, 486 So.2d 559, 561 (Fla. 1986).
- Staack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A. provided timely notice of the charging lien in accordance with Florida law on May 12, 2011, prior to the entry of a

Notice of Voluntary Dismissal in this action.

3. For reasons of law and equity, Staack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A. is entitled to a charging lien, it is hereby

#### CKDERED AND ADJUDGED that:

- 1. Snack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A. Amended Motion to Adjudicate Charging Lien and Award *In Personam* Judgment Against the Litigants in the amount of \$34,542.79 is GRANTFD.
- 2. Staack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A. shall have a lien on any recovery, fruits and real and/or p as mal property obtained by or awarded to Defendants, ANGELINE LATEK and THE ESTATE OF F (A) K LATEK, jointly and severally, in this matter.
- 3. Staack, Simms & Hernandez, P.A. n/k/a Staack & Simms, P.A., whose address is 900 Drew Street, Suite 1, Clearwater, Florida 33755, shall receiver and is awarded an *in personam* judgment against Defendants, ANGELINE LATEK and THE ESTATE OF FRANK LATEK, jointly and severally, whose address is 15225 Poplar Creek Court, Orland Park, IL 60467 and 71 Silo Ridge East, Orland Park, IL 60467, in the sum of \$34,542.79, plus prejudgment interest in the amount of \$14,790.72, making a total of \$49,333.51, that shall bear interest at the prevailing statutery interest rate of 4.75% per year from this date through December 31 of this current year, for which let execution issue. Thereafter, on January 1 of each succeeding year until the judgment is paid, the interest rate will adjust in accordance with section 55.03, Florida Statutes.

4. The Court retains jurisdiction of this action to enter further Orders that are proper.
