Transferor does hereby transfer, assign, and quit claim to Transferee all their rights, ritles and interest in and to garage right number 152, a limited common element, and hereafter the Transferee shall have the right to park one passenger vehicle per garage right in the garage comprising a part of *Metropolitan Place Condominium*. A legal description thereof is attached and made a part hereof as Exhibit "A".
- 2. Immediately upon the recording of this instrument, the aforesaid garage right shall henceforth be considered and treated as appurtenant to and shall run with the title to Unit # 806 in the inetropolitan Place Condominium.
- 3. A copy of this Amendment was delivered to the Board of Directors. There are no changes in the parties proportionate present interest in the common element.
- 4. This Amendment shall not be effective until recorded in the Office of the Recorder of Deeds of Cook County, Illinois.
