FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR HIGGINS PLACE CONDOMINIUMS

This FIRST AMENDMENT TO THE DECLARATION (hereinafter the "Declaration") OF CONDOMINIUM OWNERSHIPAND OF EASEMENTS, PESTRICTIONS, COVENANTS AND BY-LAWS FOR HIGGINS PLACE CONDOMINIUMS (hereinafter "First Amendment") is made and executed this _____ day of _____ MAY_____, 2018 by the undersigned duly authorized agent of Higgins Place Condominiums Association (the "Association").

- A. The Association was created by the recording of the Declaration with respect to the property legally described on exhibit A hereof with the Recorder of Deeds of Cook County, Illinois as document number 0412631054.
- B. There have been no subsequent amendments to the Declaration to this date.
- C. Pursuant to the provisions of the Declaration and the by-laws (the "By-laws") of the Association, the Declaration and the By-laws have been amended by signature of all members of the Board of Managers and AT LEAST two thirds of the Unit Owners of the Association held as set forth below.
- D. Attached hereto as exhibit B is an affidavit of an officer of the Association as required by Section 15 of the Declaration and Article XII of the By-laws.
- E. The Board of Managers and the Members of the Association find the amendments set forth herein to be in the best interests of the Association and its Members.

NOW THEREFORE, the foregoing recitals are incorporated herein by reference and the Association does hereby declare as follows:

- 1. The following new subsection is hereby added to Article IX of the Declaration:
 - "12. Restrictions on Leasing. No more than four (4) Units may be rented to non-owners at any one time. No Unit shall be rented for a term of less than one year. To ensure that the limitation on rented Units is not exceeded, any Owner who wishes to rent his or her Unit must first send a written notice to the Board advising the Association that the Owner would like to be able to rent the Unit. The written notice shall be accompanied by a copy of the proposed lease and a professionally prepared criminal background report on each proposed resident. Upon receiving the written notice and other required documents, the Board shall within fourteen (14) days notify the Owner if the rental limitation has been met in the Condominium, in which case the Owner shall not be permitted to rent the Unit. If a criminal background report shall disclose previous criminal convictions, the Board shall have the right to reject the lease, even if the rental limit has not been reached. Upon the termination of a lease, the renting Unit Owner shall be responsible for the cost of rekeying the exterior entry doors of the Building and providing all other owners with replacement keys.
