## **MODIFICATION OF MORTGAGE**

**THIS MODIFICATION OF MORTGAGE** dated May 29, 2018, is made and executed between **PIONEER PLAZA LLC**, whose address is 4849 N MILWAUKEE AVE #302, CHICAGO, IL 60630 (referred to below as "Grantor") and **FIRST NATIONS BANK**, whose address is 7757 W. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



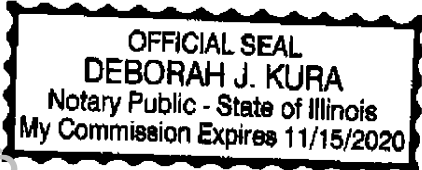

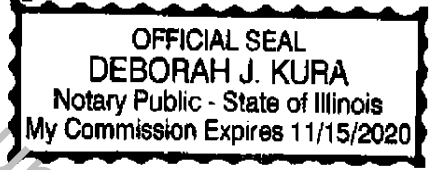
