The following are explicitly not released and remain subject to said Declaration of Trust:



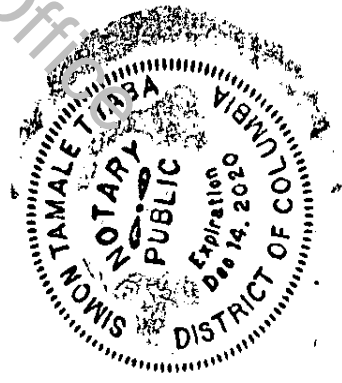
