THIS MORTGAGE ("Security Instrument") is given on April 26, 2018. The mortgagor is JOSE RODRIGUEZ AND WRGINIA ALBARRAN, HUSBAND AND WIFE, AS TENANTS BY THE ENTIRETY ("Mortgagor") has pledged the security in question to Borrower, Crump Realty Group, Inc. BORROWER COVENANTS that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property. UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.
