AMENDIVENT TO THE DECLARATION OF CONDOMINIUM FOR THE 757 ORLEANS AT CHICAGO CONDOMINIUM FOR ASSIGNMENT OF LIMITIFO COMMON ELEMENT PARKING SPACE

WHEREAS, the real estate described on Exhibit A hereto and commonly known as 757 N.

Orleans Street, Chicago, Illinois, was submitted to the Condominium Property Act of the State of Illinois (the "Act") pursuant to a Declaration of Condominium Ownership for The 757 Orleans at Chicago Condominium recorded in the Office of the Recorder of Deeds of Cook County, Illinois on October 23, 2008 as Document No. 0829718073 (as amended, the Declaration").
