If substantially equivalent Mortgage Insurance coverage is not available, Borrower shall continue to pay to Lender the amount of the septrately designated payments that were due when the insurance coverage ceased to be in effect. Lender will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage Insurance. The result of this calculation will be the new amount of my morally payment.

(D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than 6.250 % or less than 2.250 %. Thereafter, my adjustable interest rate will never be increased or uscreased on any single Change Date by more than two percentage points from the rate of interest I have been paying for the preceding 12 months. My interest rate will never be greater than 9.250 % or less than the Margin.

(E) Effective Date of Classiges

My new interest rate will become effective on each Change Date. I will pay the amount of my new monthly payment beginning on the irst monthly payment date after the Change Date until the amount of my monthly payment changes again.
