This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for the Wrigleyview Village Condominium Association (hereafter the "Association"), which Declaration was recorded on January 25, 2000 as Document Number 00063595 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit A, which is attached hereto and made a part hereof.

WHEREAS, the Declaration is silent on the procedure for amending the Declaration, this Amendment is adopted pursuant to Section 27 (a)(i) of the Illinois Condominium Property Act which provides that the Declaration may be amended by the affirmative vote of two-thirds (2/3) of the members at a regular or special meeting called for such purpose. Such amendment shall be effective upon the recordation of such instrument in the office of the Recorder of Deeds of Cook County Illinois.

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the easements, restrictions and covenants contained therein; and

WHEREAS, the Board of Directors and Owners desire to amend the Declaration in order to provide for the orderly operation of the property; and

WHEREAS, the following amendment has been approved by the affirmative vote of two-thirds (2/3) of the membership at a meeting held on July 5, 2018 which approvals are attached hereto and made a part hereof; and

WHEREAS, said the Secretary of the Board of Directors has attested to said Owner approval by execution of Exhibit B attached hereto and made a part hereof; and

WHEREAS, the effective date of the Amendment shall be the date of recordation.

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. Article VIII of the Declaration, the following shall be added as (new) Section C:

C. Lease of Units.

(1) Upon transfer of ownership of a Unit after the effective date of this Amendment, the Unit shall be owner-occupied for a period of at least two (2) years before it may be leased by the Owner. Notwithstanding the foregoing, the Board may by unanimous vote, permit an Owner to lease their Unit during this initial two (2) year period if the Owner can document significant financial hardship arising after the transfer of ownership.

(2) Notwithstanding provisions to the contrary and except as expressly contemplated by Article K below, no person or single entity may by itself or in combination with any subsidiaries or affiliates hold title to more than ten (10%) percent of the total Units of the Association, as calculated by percentage of ownership and/or number of total Units.

2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

3. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.

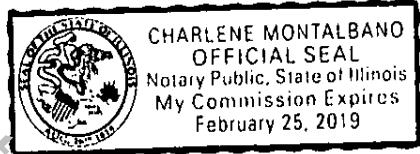


