### ORDER AUTHORIZING DEMOLITION BY THE CITY OF CHICAGO

This cause coming to be heard on July 12, 2018, on the conplaint of THE CITY OF CHICAGO ("the City"), by and through its attorney, Edward N. Siskel, Corporation Counsei, against the following:

ANJALI S. DESAI; COOK COUNTY BOARDUP, INC.: UNKNOWN OWNERS, and NONRECORD CLAIMANTS, ("Defendants").

The Court having heard evidence and testimony and being fully advised in the premises finds that:

- The Court has jurisdiction of the subject matter, which is the real estate located at 6520 S. WOLCOTT AVENUE, CHICAGO, COOK COUNTY, ILLINOIS ("subject property"), legally described as:
  - THE SOUTH 10 FEET OF LOT 8 AND THE NORTH 20 FEET OF LOT 9 IN BLOCK 39 IN SOUTH LYNNE, BEING A SUBDIVISION OF THE NORTH 1/2 OF SECTION 19, TOWNSHIP 38 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS. Permanent Index Number(s): 20-19-217-028-0000.
- Located on the subject property is a TWO STORY FRAME MULTIPLE UNIT DWELLING BUILDING ("subject building"). The last known use of the subject building was RESIDENTIAL.

- 3. The subject building is dangerous, unsafe, and beyond reasonable repair under the terms of the Illinois Municipal Code, 65 ILCS 5/11-31-1, in that the following violations of the Municipal Code of Chicago exist at the subject property and the defendants:
  - a. The building's electrical system is missing fixtures.
  - b. The building's flooring is smoke, fire, and water damaged.
  - c. The building's glazing is broken and missing.
  - d. The building's masonry is smoke, fire, and water damaged.
  - e. The building's masonry may have asbestos siding.
  - f. The building's plaster is smoke, fire, and water damaged.
  - g. The building's plumbing system is missing fixtures.
  - h. The building's rafter is fire damaged.
  - i. The building's roof has a damaged membrane and is missing shingles.
  - j. The building's sash is broken, missing, and inoperable.
  - k. The building's stairs have improper treads and risers.
  - 1. The building's studding is smoke, fire, and water damaged.
- 4. The subject building is beyond reasonable repair and it would take major reconstruction by a responsible owner to bring the subject building into full compliance with the Municipal Code.
- 5. Demolition of the subject building is the least restrictive alternative evailable to effectively abate the dangerous and unsafe conditions at the subject property as of July 12, 2018.

#### WHEREFORE, IT IS HEREBY ORDERED THAT:

- A. As the City has met its obligations with respect to property tax sale certificate holders under the Property Tax Code (35 ILCS 200/21-410) and property tax sale certificate holders are subject to, *inter alia*, Sections 21-95, 21-100, 21-105, and 22-35 of the Property Tax Code, COOK COUNTY, is dismissed as a defendant in this case and shall not be included in the term "Defendants" as used in this Order.
- B. Defendant, ANJALI S. DESAI, has failed to appear in court or otherwise answer the complaint and is in default and the complaint herein is confessed against said defendant.

- C. Defendants, ANJALI S. DESAI AND UNKNOWN OWNERS and NONRECORD CLAIMANTS, having been notified by publication and having failed to answer, appear, or otherwise plead as of the default date of June 7, 2018, are in default and all allegations in the complaint are deemed admitted against said defendants.
- D. An *in rem* judgment on Counts I and IV of the Complaint is entered in favor of Plaintiff, the City of Chicago, and against Defendants.
- E. Counts II, III, V, VI, VII and VIII of the Complaint are voluntarily dismissed, on the City's oral motion.
- F. Pursuant to the judgment entered above, 65 ILCS 5/11-31-1, and the City's police powers under Article VII of the Illinois Constitution, the City is granted authorization to demolish the subject building on the subject property, and is entitled to a lien for the costs of demolition, court costs, and other costs enumerated by creature, and/or other statutory remedies. Such authority shall be effective immediately.
- G. The City's performance under this order shall result in a statutory *in rem* lien that attaches to the subject property only. If the City seeks a personal judgment against any Defendant(s), it shall proceed by separate civil action.
- H. Any and all Defendants with either possession or control of the subject property shall immediately remove any and all persons occupying are subject building and any and all personal property from the subject property so that the subject property is completely vacant and free of persons and personal property before demolition is commenced.
- I. All Defendants and his / her / their / its agents, hears, legatees, successors, and assigns shall be permanently enjoined and restrained from renting, using, leaving, occupying, selling or otherwise transferring, in whole or in part, the ownership or controlling rate est in the entire premises until the same has / have established full compliance with the Municipal Code of the City of Chicago as stated in this cause and further order of court. Defendant(s) and his / her / their / its agents, heirs, legatees, successors, and assigns shall maintain the subject property in a sanitary, boarded, and secure condition while it remains subject to this injunction or until the property is demolished.
- J. The Court reserves jurisdiction of this cause to enforce the terms of this Order and for the purpose of ascertaining demolition costs and other costs.
- K. This matter is off-call.
