- B. Borrower's obligations under the Original Loan Agreement and Prior Note are secured inter alia by (i) a Mortgage, Assignment of Rents, Security Agreement and Fixture Filing executed as of December 14, 2016 by Assignor, as Grantor in favor of Grantee, which was recorded as Document #1635815016, Cook County, Illinois (the "Original Mortgage"), and (ii) that certain Assignment of Leases and Rents executed as of December 14, 2016 by Assignor in favor of Assignee and recorded as Document #1635815017, Cook County, Illinois (the "Assignment of Rents"), both of which encumber the property described on Exhibit "A" attached hereto.
- C. The Assignor requested and Assignee is willing to increase the principal amount of the loan.
- In connection with the such loan increase, Assignor has executed of even date herewith in favor of Assignee an Amended and Restated Promissory Note in the stated principal amount of \$91,960,000.00 (?.e "A&R Note"), which amends and restates the Prior Note (which had an outstanding principal balance of \$71,960,000.00 prior to being so amended and restated) and increases the stated principal balance by \$20,000,000.00.
- E. In connection with the execution of the A&R Note, (i) Borrower and Assignee are executing of even date herewith a first Amendment to Loan Agreement (the "<u>First Amendment</u>"), and (ii) Assigner and Assignee are executing of even date herewith a First Modification of Mortgage and Notice of Future Advance (the "<u>Mortgage Modification</u>").
- F. Assignor and Assignee decire hereby to modify the Assignment of Rents as hereinafter set forth.
- NOW, THEREFORE, for and in consideration of the mutual covenants and conditions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:
- 1. The foregoing recitals are true and correct and incorporated herein by reference as if set forth at length.
- 2. The Assignment of Rents is hereby modified such that it now secures the A&R Note, to the same extent and with the same force and effect as if the A&R Note had been executed and delivered by Borrower to Assignee at the time of the execution and delivery of the Assignment of Rents.
- 3. All references in the Assignment of Rents to the term "Loan" shall herein after be deemed to mean the loan in the principal amount of \$91,960,000.00 made by Assignee to Borrower as evidenced by the A&R Note (defined in Recital D above).
- 4. All references in the Assignment of Rents to the term "Loan Agreement" shall hereinafter be deemed to mean the Original Loan Agreement (defined in Recital A above) as modified by the First Amendment (defined in Recital E above), as the same may be amended, modified or extended from time to time.
- 5. All references in the Assignment of Rents to the term "Note" shall hereinafter be deemed to mean the A&R Note (defined in Recital D above), as the same may be amended, modified or extended from time to time.
- 6. All references in the Assignment of Rents to the term "Mortgage" shall hereinafter be deemed to mean the Original Mortgage (defined in Recital B above) as modified by the Mortgage
