THIRD AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR THE RIVER WEST VILLAGE LOFTS CONDOMINIUM ASSOCIATION

This document is recorded for the purpose of amending the Declaration of Condominium (hereafter the "Declaration") for River West Village Lofts Condominium Association (hereafter the "Association"), which Declaration was recorded on September 3, 1993, as Document No. 93706515 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit A, which is attached hereto and made a part hereof.

This Third Amendment (the "Third Amendment") is adopted pursuant to Section 27 of the Illinois Condominium Property Act (the "Act") and Article 15.08 of the Declaration. Said provisions provide that this Third Amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same a executed by all of the Members of the Board of the Association and approved by at least sixty even percent (67%) of the total vote of the Unit Owners.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Third Amendment has been approved by at least sixty seven percent (67%) of the total vote of the Unit Owners, and signed and acknowledged by the President of the Board, all in compliance with Section 27 of the Act and Article 15.08 of the Declaration.

WHEREAS, the Board and the Unit Owners desire to amend Article IX of the Declaration, titled "Sale of the Property" to reduce the ownership approval threshold from one hundred percent (100%) to seventy-five percent (75%), so that it is consistent with Section 15 of the Act.



WHEREAS, the Board and the Unit Owners further desire to remove the provision from Article IX and XI(e)(iii) of the Declaration which require mortgagee approval of any future sale of the Property.

NOW THEREFORE, Article IX of the Declaration is hereby deleted in its entirety, and replaced with the following new Article IX;

SALE OF PROPERTY

A' a meeting duly called for such purpose, the Unit Owners by affirmative vote of at least secenty five (75%) of the Unit Owners, may elect to sell the Property as a whole. Such action shall be binding upon all Unit Owners and it shall thereupon become the duty of every Unit Owner to execute and deliver such instruments and to perform all acts as in manner and form may be necessary to effect such sale.

NOW THEREFORE, Article XI(e)(iii) of the Declaration (which contains the following clause; "the sale of the Property") shall be deleted in its entirety from the Declaration.

NOW THEREFORE, except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
