Be It Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation, or any of her designees is each hereby authorized and directed to approve a proposed Pullman Park-Phase 5 Subdivision being a resubdivision of certain lots owned by Pullman Park Development LLC ("Developer") in the block bounded by East 107<sup>th</sup> Street, South Doty Avenue, East 111<sup>th</sup> Sureet and approximately South Maryland Avenue, and legally described in the attached plat (Exhibit A, CDOT File: 25-09-18-3853) which, for greater certainty, is hereby made a part of this ordinance.
