# AMENDMENT TO DECLARATIONOF CONDOMINIUM OWNERSHIP FOR 1400 STATE PARKWAY CONDOMINIUM ASSOCIATION

This Amendment to the Declaration of Condominium Ownership and Plat of Survey for 1400 State Parkway Condominium Association is an amendment to that certain Declaration of Condominium Ownership for 1400 State Parkway Condominium Association recorded in the office of the Recorder of Deeds of Cook County, Illinois, on October 4, 1979, as Document No.25179002 ("Declaration").

#### WITNESSETH:

WHEREAS, certain real property located in the City of Chicago, Cook County, Illinois, has been submitted to the provisions of the Illinois Condominum Property Act ("Act") and the Declaration, such condominium being known 1400 State Parkway Condominium Association, which real property is legally described in Exhibit "A" (incorporated berein and attached hereto); and

WHEREAS, 1400 State Parkway Condominium Association, an Illinois not-for-profit corporation ("Association"), administers the property as set forth and described in the Declaration and the By-Laws for 1400 State Parkway Condominium Association; and

WHEREAS, pursuant to Section 31 of the Act, a Unit Owner may, at the Unit Owner's own expense, subdivide or combine his or her Unitand locate or relocate common elements affected or required thereby, in accordance with the provisions of the Condominium Instruments and the requirements of the Act. Section 31 of the Act provides further that the Unit Owner shall make written application to the Board of Managers, requesting an amendment to the Condominium Instruments, setting forth in the application a proposed reallocation to the new Units of the percentage interest in the Common Elements and setting forth whether the Limited Common Elements, if any, previously assigned to the Unit to be subdivided should be assigned to each new Unitor to fewer than all of the new Units created. Section 31 of the Act provides further that if the subdivision is approved by a majority of the Board of Managers, it shall be effective upon (1) recording of an amendment to the Condominium Instruments in accordance with Sections 5 and 6 of the Act; and (2) execution by the Owner of the Unit involved; and

WHEREAS, the Owner of Unit Number 12E and Unit Number 12F wishes to reconfigure said Units and adjoining Common Elements and to amend the Declaration to reflect this transaction; and

WHEREAS, the current percentage interest in the Common Elements assigned by the Declaration to Unit Number 12E is .0094 and Unit Number 12F is .00125; and

WHEREAS, the Owner of Unit Number 12E and Unit Number 12F has submitted a written application to the Board of Managers of the Association requesting an amendment to the Condominium Instruments and setting forth in such application a proposed reallocation of the two Units of the percentage interests in the Common Elements; and

WHEREAS, a majority of the Board of Managers of the Association has approved the reconfiguration of Unit Number 12E and Unit Number 12F as described by this amendment and reflected in the Amended Plat of Survey; and

WHEREAS, this amendment has been executed by the President of the Association and the Owner of Unit Number 12E and Unit Number 12F in compliance with the Act.

NOW, THEREFORE, the Association and the Owner of Unit Number 12E and Unit Number 12F hereby declare that the Declaration be and hereby is amended as follows.

1. Exhibit "A" to the Declaration is hereby amended to reflect the reconfiguration of Unit Number 12E and Unit Number 12F, which Units shall continue be described as Unit Numbers 12E and 12F, respectively, and to reflect the reallocation of said Units' percentage interests in the Common Elements as provided below and as shown on the revised Exhibit "B" to the Declaration attached hereto and by reference made a part hereof:

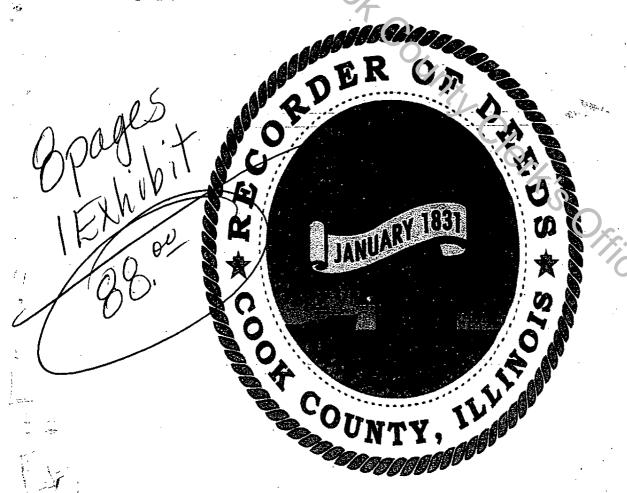
