# AMENDMENT FO CONSTRUCTION MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF RENTS AND LEASES AND FIXTURE FILING

This Amendment to Construction Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing (this "Amendment") is entered into as of August 24, 2018 by and between TCA-2020 WEST, L.L.C., an Illinois limited liability company, (the "Mortgagor"), with an address at 3611 N. Kedzie Avenue, Chicago, Illinois 60618 and JPMORGAN CHASE BANK, N.A., a national banking association (the "Mortgagee"), with an address at 10 S. Dearborn Street, Floor 35, Chicago, Illinois 60603.

### RECITALS

WHEREAS, the Mortgagor and the Mortgagee are party to a Construction Loan Agreement dated as January 4, 2017 (as amended, the "Original Loan Agreement");

WHEREAS, the Mortgagor has previously executed an Construction Loan Note dated January 4, 2017 (the "Original Note") in favor of the Mortgagee, which Original Note was amended and restated pursuant to an Amended and Restated Construction Loan Note dated January 10, 2018 (the "Existing Note");

WHEREAS, contemporaneously herewith the Mortgagor and the Mortgagee are entering into a Second Amendment to Construction Loan Agreement and First Amendment to Amended and Restated Construction Loan Note (the "Loan Document Amendment"; the Original Loan Agreement as so amended and as it may from time to time be further amended, restated, supplemented or otherwise modified from time to time is referred to herein as the "Loan Agreement" and the Existing Note as so amended and as it may from time to time be further amended, restated, supplemented or otherwise modified from time to time is referred to herein as the "Note", the obligations under each of which are referred to herein as the "Loan");

WHEREAS, to secure the Loan and certain other obligations described therein (the "Obligations"), the Mortgagor executed and delivered a Construction Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing dated as of January 4, 2017 (the

"Existing Mortgage") encumbering land legally described in Exhibit A hereto. The Existing Mortgage was recorded in the office of the Cook County Recorder of Deeds on January 4, 2017 as Doc. No. 1700445090. Any capitalized term used in this Amendment that is not otherwise defined herein shall have the definition given in the Loan Agreement; and

WHEREAS, the Mortgagee has required that the Mortgagor enter into this Amendment to confirm that the Existing Mortgage, as amended hereby, secures the Obligations as modified by the Loan Document Amendment and all other obligations under the Loan Agreement and the Note.

### **AGREEMENT**

NOW, THEREFORE, the Mortgagor and the Mortgagee agree as follows

- 1. Incorporation of Recitals. The foregoing Recitals are true and accurate.
- 2. <u>Amendment of Existing Mortgage Provisions.</u> Recital (A) of the Existing Mortgage is hereby amended to read in its entirety as follows:
  - Pursuant to the terms and conditions contained in that certain Construction A. Loan Agreement dated as of even date herewith, executed by and between the Mortgagor and the Lender (the "Loga: Agreement"), the Lender has agreed to loan to the Mortgagor the principal amount of TWENTY FIVE MILLION and 00/100 Dollars (\$25,000,000.00) (the "Loan"). The Loan shall be evidenced by that certain Promissory Note of even date herewith (as amended, restated or replaced from time to time, the "Note"), executed by the Mortgagor and made payable to the order of the Lender in the original principal amount of the Loan and due on August 1, 2028 (the "Maturity Date"), except as may be occelerated pursuant to the terms hereof, of the Note, the Loan Agreement or of any other document or instrument now or hereafter given to evidence or secure the payment of the Note or delivered to induce the Lender to disburse the proceeds of tre Loan (the Note and the Loan Agreement, together with such other documents, as amended, restated or replaced from time to time, being collectively referred to herein as the "Loan Documents"). All capitalized terms which are not defined hereir shall have the meanings ascribed thereto in the Loan Agreement.

### 3. The Amended Loan Documents.

- (a) The term "Mortgage" as used in this Amendment shall mean the Existing Mortgage, as amended hereby and as it may from time to time be further amended, restated, supplemented, replaced or otherwise modified.
- (b) All references in the Mortgage to the Loan Agreement or the Note as in effect prior to giving effect to the Loan Document Amendment shall be deemed references to the Loan Agreement or the Note, as applicable.

- (c) All references in the Mortgage to any instrument as evidence of the Indebtedness shall be deemed references to the Loan Agreement, the Note and any other instrument(s) issued to additionally evidence any portion of the Indebtedness pursuant to the Loan Agreement.
- (d) The term "Loan Documents", as used in the Mortgage, shall mean, in addition to those documents included within such term by the Loan Agreement, prior to giving effect to the Loan Document Amendment, all such documents as specified by reference to the Loan Agreement, as all such documents heretofore may have been and may hereafter from time to time be amended, restated, supplemented or modified.
- (e) This Amendment and the Existing Mortgage as amended hereby shall each be considered a "Loan Document" under and as defined in the Loan Agreement.
- 4. <u>Priority</u>. Nothing contained herein shall in any manner affect or impair the priority of the lien of the Existing Mortgage as to the indebtedness secured thereby prior to giving effect to this Amendment, nor affect any other security held by the Mortgagee to secure repayment or performance of the obligations referred to therein. The Mortgagor confirms that the Mortgage secures the time!y payment and the timely performance of all Indebtedness (as references to that term are modified in <u>Section 3</u> above), as and when required.
- 5. <u>Reaffirmation</u>. The increagor hereby repeats, reaffirms and remakes all representations, warranties, covenants and agreements contained in the Existing Mortgage as of the date of this Amendment.
- 6. <u>Representations</u>. The Mortgagor represents and warrants that (i) no default or event of default currently exists under the Existing Mortgage and (ii) no condition exists which with the giving of notice or the passage of time, or both, would result in such a default or event of default.
- 7. <u>Full Force and Effect</u>. All of the provisions, rights powers and remedies contained in the Existing Mortgage shall stand and remain unchanged and in full force and effect, except to the extent specifically amended hereby.
- 8. References. No reference to this Amendment need be made in any instrument or document at any time referring to the Existing Mortgage, and any reference in any such instrument or document to the Existing Mortgage shall be deemed to be a reference to the Mortgage.
- 9. <u>Governing Law</u>. This Amendment shall be construed in accordance with and governed by the internal laws of the state where the Land is located.
- 10. <u>Time of the Essence</u>. Time is of the essence with respect to the payment and performance of all obligations to be performed under the Mortgage.
- 11. <u>Successors and Assigns</u>. The Mortgage binds the Mortgagor and its successors, assigns, heirs, administrators, executors, agents and representatives and inures to the benefit of the Mortgagee and its respective successors, assigns, heirs, administrators, executors, agents and representatives.

No consent or approval of the Mortgagee shall be given or deemed to have been given except to the extent expressly set out in a writing executed and delivered by the Mortgagee to the Mortgagor.
- 14. <u>WAIVERS</u>. THE MORTGAGOR HEREBY REPEATS, REAFFIRMS AND REMAKES ALL WAIVERS CONTAINED IN THE EXISTING MORTGAGE AS OF THE DATE OF THIS AMENDMENT, INCLUDING (WITHOUT LIMITATION) THE WAIVER OF JURY TRIAL CONTAINED IN THE EXISTING MORTGAGE.
