NOTICE OF REVIVED JUDGMENT LIEN

On November 8, 2011, a judgment (the "*Judgment*") in the amount of \$457,499.94 was entered in the Circuit Court of Cook County, Illinois, in favor of plaintiff FirstMerit Bank, N.A., and against defendant Mitchell B. Squire (the "*Judgment Debtor*"), whose last known address is 1708 W. Jarvis Ave., Chicago, Illinois 60626. On November 9, 2011, FirstMerit Bank recorded a Memorandum of Judgment with the Cook County Recorder of deeds as document number 1131344065 (the "*Memorandum of Judgment*"). The Huntington National Bank ("*Huntington*") is the successor in interest to FirstMerit Bank with regard to the Judgment and was substituted as the plaintiff by court order. On September 13, 2018, the Circuit Court of Cook County, Illinois entered an Order reviving the Judgment in accordance with 735 ILCS 5/2-1602. Attached as Exhibit A is a certified copy of the September 13, 2018, Order. The recording of this memorandum shall constitute a lien on any and all property owned by the Judgment Debtor or his estate in Cook County Illinois.

ORDER REVIVING JUDGMENT


