## AMENDED ORDER FOR REVIVAL OF JUDGMENT

THIS CAUSE coming on to be heard on the Petition of Plaintiff to Revive a Judgment, the Defendant having been served and given an opportunity to be heard, the Court does find, based upon the allegations of the petition:

1. A judgment in favor of **FLORIDA FINANCIAL GROUP, LLC** and against **CHRISTOPHER FEURER** and **KRISTEN STOJENTIN FEURER** was entered in this Court on **October 17, 2011**, in the amount of **\$518,246.58**, plus costs of suit.

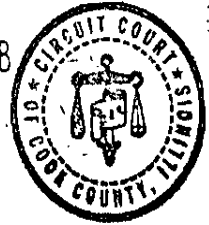
