THIS MODIFICATION OF MORTGAGE dated September 1, 2018, is made and executed between Paul H. Buehler, as Trustee of The Paul H. Buehler Declaration of Trust dated April 14, 2016 (referred to below as "Grantor") and First Bank & Trust, a Division of Byline Bank, whose address is 820 Church Street, Evanston, IL 60201 (referred to below as "Lender").

MODIFICATION Lender and Grantor hereby modify the Mortgage as follows:

The paragraph entitled "Note" in the Mortgage and Assignment of Rents is hereby deleted and replaced with the following:

Note. The word "Note" means (a) the promissory note dated September 1, 2018 in the original principal amount of \$582,863.11 executed by Paul H. Buehler ("Note 1") and (b) the promissory note dated March 27, 2018 in the original principal amount of \$250,000.00 executed by New Specialty Products, Inc. ("Note 2") and (c) the promissory note dated September 15, 2015 and Change in Terms Agreement dated June 28, 2016 in the original principal amount of \$525,000.00 executed by New Specialty Products, Inc. ("Note 3"). Notes 1, 2 and 3 together with all renewals of, extensions of, amendments of, modifications of, refinancing of, consolidations of, substitutions of and replacements thereof, are hereinafter collectively referred to as the "Note". **NOTICE:** Under no circumstances shall the interest rate on this Mortgage be more than the maximum rate allowed by applicable law. **NOTICE TO GRANTOR: THE NOTE IN THE AMOUNT OF \$250,000.00 TO NEW SPECIALTY PRODUCTS, INC. CONTAINS A VARIABLE INTEREST RATE.**

All other terms and conditions not specifically amended herein, remain unchanged and in full effect.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

GRANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS MODIFICATION OF MORTGAGE AND GRANTOR AGREES TO ITS TERMS. THIS MODIFICATION OF MORTGAGE IS DATED SEPTEMBER 1, 2018.

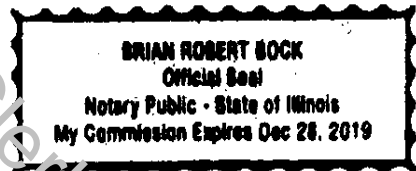

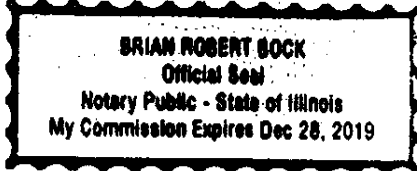
