THE COURT FINDS:

- That on April 20, 2017, Globerrotters Engineering Corporation was appointed limited receiver for the purpose of performing specific task: at the subject premises.
- That Receiver performed specific task: as detailed in the third & final accounting for fees and expenses 2. from February 17, 2018 through and including July 24, 2018.
- That Receiver's third & final accounting states that, in the course of fulfilling its duties, Receiver 3. incurred out of pocket costs totaling \$0.00, and that \$6,070.15 in fees were billed for a combined total of \$6,070.15.
