### ASSIGNMENT AND ASSUMPTION OF LEASE

Assignee agrees to indemnity, protect, defend and hold Assignor and its officers, directors, members, partners, shareholders, employees and agents harmless from and against any third party Losses relating to the Lease and first arising or accruing at any time from and after the date hereof.
- 3. This Assignment shall be binding on and inure to the benefit of the parties hereto, their successors and assignees.
