This Amendment to the Declaration of Condominium Ownership For The Huron-Wells Condominium Association, made and entered into this <u>Mr</u> day of <u>October</u> 2018, by the affirmative approval of Unit Owners being at least seventy-five percent (75%) of the total ownership of the Common Elements of the Association.

WITNESSETH

WHEREAS, by a certain Declaration of Condominium Ownership For Huron-Wells Condominium, filed in the Office of the Feorder of Cook County, Illinois, on the 23rd day of October, 1979, as Document No. 25206179 (hereinafter referred to as "Declaration") the real estate legally described therein and described on Exhibit A attached hereto, was submitted to the Condominium Property Act of the State of Illinois, and to the covenants, conditions, rights, and restrictions set forth in the Declaration; and

WHEREAS, the Declaration was amended by an Amendment to the Declaration filed with the Recorder of Deeds of Cook County, Illinois on August 30, 2017 as Document No. 1724244002; and,

WHEREAS, Article XIII, Paragraph (A) of the Declaration provides that the provisions of the Declaration may be changed, modified, or rescinded by an instrument in writing setting forth such change, modification or rescission, signed by Unit Owners owning not less than seventy-five percent (75%) of the total ownership of the Common Elements, and provided that all lien holders of record have been notified by certified mail of such change, modification or rescission, and an affidavit by the Secretary of the Association certifying to such mailing is made a part of such instrument; and

WHEREAS, the Unit Owners desire at this time to allow the current operator of the Commercial Unit to sell beer and wine in connection with the current operation of the Commercial Unit and incidental to the primary business purposes of the Commercial Unit;

NOW THEREFORE, by this written instrument, approved by Unit Owners being at least seventy-five percent (75%) of the total ownership in the Common Elements, the Declaration is hereby amended as follows:

- 1. The Declaration is amended at Article IX, Paragraph A.(2), by modifying subparagraph (d) to read as follows (underline indicates words added):
 - d) the commercial use does not involve the sale of alcoholic beverages (except as permitted by Paragraph A.(3) of this Article IX, or of "modeling, dating, massage, and/or escort services," or of so-called "adult, pornographic or prurient books or materials;"
- 2. The Declaration is amended at Article IX, Paragraph A, by adding new Paragraph A.(3) as follows:
 - (3) The commercial unit, Unit 164-1A, presently owned by MAC Wells Condo, LLC and operated by Jon Schiff as a company commonly known as Real Good Juice Company, is permitted to sell and serve beer and wine as a part of its business operation subject to the following:
 - (a) Unit 164-1A is permitted to sell and serve beer and wine only for so long as Jon Schiff as Real Good Juice Company is the operator of Unit 164-1A. In the event that Jon Schiff no longer, directly or indirectly, has an ownership or controlling interest in Real Good Juice Company or its operations, and notwithstanding anything in this Paragraph A.(3), the Board shall have the right and authority to promibit all sales and service of alcohol from the premises if, thereafter, the operation of the business changes materially in a way that negatively impacts the members of the Association. The Board shall first notify Real Good Juice Company of the negative impact and allow Real Good Juice Company of reasonable opportunity to address the negative impact, and if such negative impact is not resolved, or cannot be resolved, to the satisfaction of the Board, the Board may prohibit sales and service of alcohol, including beer and wine.
 - (b) At all times, the Unit Owner and/or operator as appropriate shall maintain a valid liquor license, and any other operating license, as required by the City of Chicago, and any other governmental authority with jurisdiction. No sales of beer or wine shall occur at anytime without a valid liquor license.

- (c) Only sale of beer and wine is permitted. No other alcohol or liquor may be sold or served in any manner or form. The sale and service of beer and wine shall not be the primary purpose of the business of Unit 164-1A, but shall only be incidental to the operation and business of Unit 164-1A as the business operation exists on the effective date of this amendment.
- (d) No sales or service of beer or wine are permitted after 10:00 p.m. on Friday and Saturday, after 9:00 p.m. on Sunday through Thursday, and prior to 8:00 a.m. on any day, notwithstanding any permissions granted by the City of Chicago in connection with any license issued.
- (e) The sale and service of beer and wine shall be further subject to reasonable rules and regulations adopted by the Board of Managers as determined by the Board to be in the best interests of the Association and its Units, Unit Owners, and residents, provided that such rules shall not conflict with the provisions of this Section A.(3) or any other rights or provisions of Unit Owner or Real Good Juice Company in the Declaration.

This Amendment shall be effective on the date it is filed with the Recorder of Deeds of Cook County, Illinois.
