# AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE LANDMARK OF WILMETTE CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws (hereafter the "Declaration") for The Landmark of V/ilmette Condominium Association (hereafter the "Association") and the Plat of Survey as Exhibit "A" to the Declaration that were recorded on December 28, 1977 as Document No. 242629:6, and covers the property (hereafter the "Property") legally described in Exhibit "1", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Section 5 and Section 27(b) of the Illinois Condominium Property Act (the "Act"), 765 ILCS 605/ 5 and 27.

#### **RECITALS**

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Plat of Survey ("Plat") of the Parking Spaces required by Section 5 of the Act is attached to the Declaration as Exhibit "A"; and

WHEREAS, Section 5 of the Act requires the Plat to accurately depict the boundaries of the Parking Spaces; and

WHEREAS, the Plat does not accurately depict the boundaries or location of the Parking Spaces as actually constructed; and

WHEREAS, Section 5 and Section 27(b) of the Act provides a procedure for amending the Plat to correct such an omission and error; and

NOW THEREFORE, Page 1 or Exhibit "A" (Plat of Survey) to the Declaration of Condominium for Landmark of Wilmette Condominium is hereby deleted in its entirety and replaced with Amended Page 1 of Exhibit "A" attached hereto as Exhibit "2."

Except as expressly provided in this amendment, the remaining provisions of the Declaration are hereby confirmed and ratified and shall continue in full force and effect without change.


