- 1,- Increase the loan amount to \$698,331.00, the current balance is \$393,017.07.
- 2,- Change the repayment to; 12 months interest only at 5.50% fixed.
- 3.- Followed by a 4 year amortizing period P&I at 5.50% fixed.
- 4,- Followed by a 5 year amortizing period of P&I at 3.50 above the then most recently available 5-year U.S. Treasury constant maturity Index. The current index is 2,94%, with a floor of 5.25% and a ceiling of 8.50.
- 5.- We will continue to collect monthly real estate tax escrow for the 76th Ave only.
