#### WITNESSETH:

WHEREAS, HUD insured or coinsured a mortgage loan (the "Mortgage Loa.") evidenced by a Mortgage Note dated September 1, 2012, in the original amount of \$13,658,000.00 (the "Mortgage Note"), and secured by a Mortgage dated as of September 1, 2012, as assigned, amended or modified from time to time (the "Mortgage"), on Project No. 071-22210, located in Cook County, Illinois (the "Project");

WHEREAS, HUD has entered into a certain Loan Sale Agreement with Laureate Mortgage, LLC (the "Purchaser"), dated as of August 15, 2018, (the "Loan Sale Agreement"), pursuant to which HUD is selling, assigning and transferring the Mortgage Loan to the Purchaser; and

WHEREAS, pursuant to the Loan Sale Agreement, HUD has agreed to release the Regulatory Agreement as provided below.

NOW, THEREFORE, for and in consideration of the sale, assignment and transfer of the Mortgage Loan, and other good and valuable consideration, the adequacy and receipt of which are hereby acknowledged, HUD does hereby release and terminate, but on a prospective basis only, the Regulatory Agreement in effect with respect to the Project and does hereby agree that the Lessee and its successors and assigns are released, on a prospective basis only, from all obligations set forth in the Regulatory Agreement (including, without limitation, obligations relating to the maintenance of any reserve fund for represements referenced in the Regulatory Agreement); provided, however, that (i) this Release shall be of no further force or effect and the Regulatory Agreement shall not be released if HUD rescinds the sale, assignment and transfer of the Mortgage Loan pursuant to the Loan Sale Agreement; and (ii) nothing in this Release shall waive, compromise, impair or prejudice any right that HUD might have to seek judicial, administrative or other recourse for any breach of the Regulatory Agreement that might have occurred or accrued prior to the date of this Release, or to pursue any claim for violation or breach of the Regulatory Agreement pursuant to a Proof of Claim.
