

- 1. Affiant makes this Affidavit based upon her position as the individual responsible for the electronic filing of documents with the Cook County Recorder of Deeds on behalf of First American Title Insurance Company and her knewledge of the error that occurred in the filing of the above referenced document number.
- 2. That on November 5, 2018, Affiant was directed to submit for recording the First Modification of Mortgage and Other Related Document by and among ARCHWAY OIL, LLC, an Illinois limited liability company, and WINTRUST BANK, an Illinois banking corporation ("Mortgage Modification") to be posted against the real property attached hereto as Exhibit A.
- 3. Said Mortgage Modification was filed utilizing the Simplifile system as permitted by the Cook County Recorder of Deeds for filing of certain documents by electronic means.
- 4. Upon the scanning of the Mortgage Modification as required in order to file electronically, the first page of the document, through a misfeed that was not detected, failed to transmit the third line of the first paragraph of the document that begins with "14" and ends with "liability," thus omitting the full date of the document as well as the name of the Mortgagor, Archway Oil, LLC, an Illinois limited liability company.
- 5. As a consequence of this misfeed, the first page of the document was not fully scanned and correctly transmitted.
