This amendment is adopted pursuant to the provisions of Paragraph 22 of the aforesaid Declaration and Section 17 and Section 18.8(e) of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed by all of the members of the Board, and by at least seventy five percent (75%) of the Unit Owners, and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees having liens of record against any Unit, not less than ten (10) days prior to the date of such affidavit.

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to prohibit smoking on the Property; and

WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board, signed by all of the Board members and by at least seventy fiver percent (75%) of the Unit Owners, and due notice having been provided to all mortgagees holding liens of record against any Unit, all in compliance with Paragraph 22 of the Declaration and Section 17 and Section 18.8(e) of the Act.

NOW THEREFORE, Paragraph 19 of the First Consolidated, Amended and Restated Declaration of Condominium Ownership and of Easements, Restrictions and Covenants and By-Laws for 1130 Ontario Condominium Association is hereby amended in accordance with the text which follows (additions in faxt are indicated by double underline; deletions by strike-outs):

"(s) Smoking of tobacco, eaves, or any other plant of any kind, is prohibited in any portion of the Property, including the Common Elements (including, but not limited to, within fifteen (15) feet of any doors or windows) Limited Common Elements, and the individual Units."

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration and By-Laws shall continue in effect without change.


