This matter coming to be heard upon the Petitions for Rule to Show Cause, Petition for Contribution to College Expenses, and Petition to Modify Child Support filed by the Respondent, both parties represented by counsel, the parties being in agreement, and being fully advised in the premises;

It is hereby agreed as follows:

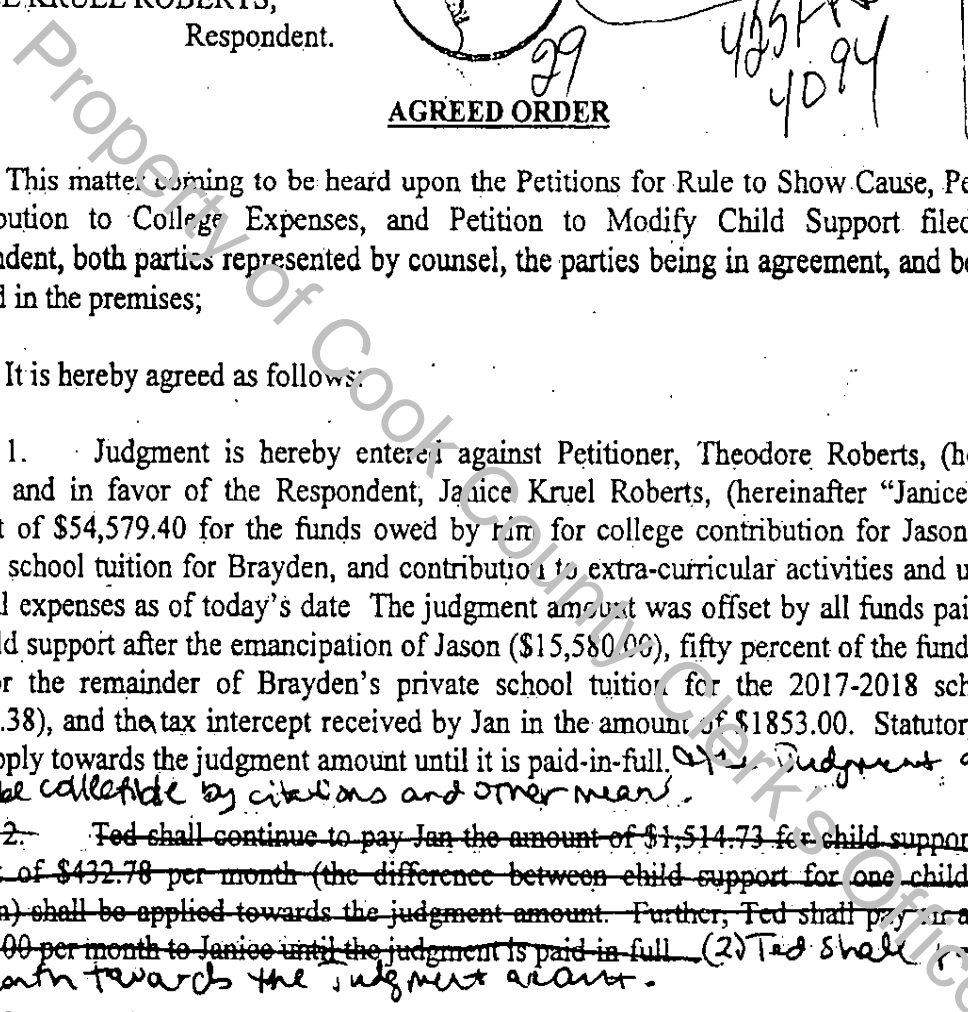
1. Judgment is hereby entered against Petitioner, Theodore Roberts, (hereinafter "Ted") and in favor of the Respondent, Janice Kruel Roberts, (hereinafter "Janice") in the amount of \$54,579.40 for the funds owed by him for college contribution for Jason Roberts, private school tuition for Brayden, and contribution to extra-curricular activities and uncovered medical expenses as of today's date. The judgment amount was offset by all funds paid by Ted for child support after the emancipation of Jason (\$15,580.00), fifty percent of the funds paid by Ted for the remainder of Brayden's private school tuition for the 2017-2018 school year (\$2511.38), and the tax intercept received by Jan in the amount of \$1853.00. Statutory interest shall apply towards the judgment amount until it is paid-in-full. *Judgment amount shall be collected by citations and other means.*

~~2. Ted shall continue to pay Jan the amount of \$1,514.73 for child support and the amount of \$432.78 per month (the difference between child support for one child vs. two children) shall be applied towards the judgment amount. Further, Ted shall pay an additional \$1,500.00 per month to Janice until the judgment is paid-in-full.~~ *(2) Ted shall pay \$500.00 per month towards the judgment amount.*

~~3. Ted shall tender \$\_\_\_\_\_ to Jan to be applied towards the Judgment amount within sixty (60) days.~~ *3. Ted shall pay \$1,081.95 per month as child support pursuant to the parties' Ms A + Uniform order for support to be entered by separate order.*

4. The remaining College Illinois Plan credits, that were not utilized for Jason, shall be applied to Brayden's college tuition and expenses. After the application of the College Illinois Plan, the parties shall equally pay all of Brayden's college tuition, room and board, book costs, roundtrip travel between school and home, uncovered medical expenses, and other incidental expenses. All payments shall be made timely and if one party pays an expense in-full, the other party shall reimburse for his or her share within thirty (30) days of receiving proof of the expense.

5. ~~Ted shall pay Janice \$\_\_\_\_\_ towards her attorney's fees incurred in this~~ *Each party shall reimburse the other party for all uncovered medical and extra-curricular activity for the within 30 days of receiving notice of the expense.*






6. If Ted fails to comply with this Order, he shall be solely responsible for all attorneys' fees and costs incurred by Janice to seek compliance.
