Brown Street, Suite 300, Birmingham, Michigan 48002, hereby grants, assigns, and transfers to and in favor of LIBERTY BANK ("Assignee"), having an office located at 315 Main Street, Middletown, CT 06457, all of the Assignor's right, title and interest as mortgagee under those certain hereinafter described timeshare interest mortgage(s) (the "Mortgage(s)") and all powers, covenants and provisions therein contained, together with the promissory note(s) secured by such Mortgage(s) (the "Note(s)"), all monies due and to become due on account of such Mortgage(s) and Note(s), and all rights, if multiple Mortgages, accrued or to accrue under such Mortgages and Notes.
