1. Payment of Principal and Interest. - 3. Charges; Liens. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, costs of documentary evidence, abstracts, title reports and reasonable attorney's fees.

18. Borrower's Right to Redeem. Borrower shall have such rights of redemption as are provided by the law of the State where

the Property is located.

19. Waiver of Homestead. Borrower has waived all rights of homestead exemption in the property.

20. Assignments of Rents.
