AN ORDINANCE AMENDING THE ZONING MAP WITH REGARD TO THE PROPERTY LOCATED AT 8119-8149 FLORAL AVENUE SKOKIE, ILLINOIS FROM A CX CORE MIXED-USE DISTRICT TO AN R4 MULTIFAMILY RESIDENCE DISTRICT

WHEREAS, the owners of the following described real property:

WHEREAS, this case was presented with companion Plan Commission Cases 2018-04P (Chapter 118 code amendment), 2018-05P (plat of subdivision) and 2018-07P (site plan approval); and

WHEREAS, the Subject Property is currently vacant and the petitioners desire to rezone the property to R4 Multifamily Residence in order to redevelop the property and construct a planned development that includes eight (8) townhouse residences facing Floral Avenue and eight (8) mixed-use commercial/residential units facing Lincoln Avenue; and

WHEREAS, the Lincoln Avenue property will remain zoned CX Core Mixed-Use; and

WHEREAS, the zoning amendment is necessary as the townhouse residences are not allowable uses in the CX district and the commercial/residential units are not compatible with the recent single-family residential development on the west side of Floral Avenue; and

WHEREAS, R4 zoning is an appropriate zone for the townhouse residences as it provides a low-intensity transition from the CX-zoned property on the eastern portion of the Subject Property to the single-family residences on the west side of Floral Avenue and west of the Subject Property; and

WHEREAS, the Skokie Plan Commission, after public hearing duly held on April 5, 2018, at which no interested parties testified, (i) determined that proper notice had been given; (ii) made the appropriate findings of fact in the affirmative as required under Section 118-6(h) of the Skokie Village Code and (iii) voted to recommend to the Mayor and Board of
