#### UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- Payment of Principal; Prepayment and Late Charges. Borrower shall promptly pay when due the
  principal of the debt evidenced by the Note and any prepayment and late charges due under the Note
  and any sums advanced under paragraph 7.
- 2. Intentionally Deleted.
- 3. Ar oblication of Payments. Unless applicable law provides otherwise, all payment received by Lender under paragraph 1 shall be applied first to any amounts advanced under paragraph 7, then to any late charge: due under the Note and then to principal due.
