THIS INDENTURE WITNESSETH, that the Grantor,

of the County of Cook and State of Illinois, for and in consideration of 10.00 Dollars, and other good and valuable considerations in hand paid, conveys and warrants unto ATG TRUST COMPANY, One South Wacker Drive, Chicago, Illinois 60606-4654, an Illinois Corporation, as trustee under the provisions of a trust agreement dated the 30th day of January, 2019, known as Trust Number L019-014, the following described real estate in the County of Cook and State of Illinois, to wit:
