- 3. On or about November 1, 2018, Contractor made an oral subcontract with Claimant to do interior painting and concrete repairs at the Erroperty.
- 4. On December 13, 2018, Claimant completed all work required to be done by the contract.
- 5. Contractor is entitled to credits in the amount of \$1,800, leaving due, unpaid, and owing to Claimant, after allowing all credits, the sum of FOUR THOUSAND DOLLARS (\$4,000).
- 6. The Claimant claims a lien of **FOUR THOUSAND DOLLARS (\$4,00°)** plus interest, against Contractor and Owner on the land and improvements of the Property, and on the money or other consideration due or to become due from Owner's contract with Contractor.
