whereas, the original Plat of Survey attached as Exhibit "A" to the Declaration of Condominium Ownership (i) failed to depict the garage roof and (ii) failed to set forth the four (4) roof decks located on the garage roof as limited common elements for Units 2N, 25, 103 and 104 respectively, as more fully set forth on revised page 2 of the Plat of Survey attached hereto.

NOW, THEREFORE, the Declaration of Condominium Ownership for The 2649 North Racine Condominiums, Chicago, Illinois is hereby amended as follows:

- 1. The garage roof of the building is hereby depicted on revised page 2 of the Plat of Survey attached hereto and made a part hereof. There are four (4) roof decks which have been built on said garage roof, each such roof deck being a limited common element to the unit set forth on the said revised page 2 of the Plat of Survey.
- 2. Page 5 of the Plat of Survey, attached hereto, hereby substituted for page 5 of the Plat of Survey attached as Exhibit "A" to the Declaration.
- 3. That except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.


