# LIMITED COMMON ELEMENT STORAGE SPACE TRANSFER AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR CLOCK TOWER POINTE OF HARWOOD HEIGHTS CONDOMINIUM ("CLOCK TOWER")

The document is recorded for the purpose of amending the Declaration of Condominium Ownership (hereafter the "Declaration") for Clock Tower Pointe of Harwood Heights Condominium ("Clock Tower") (hereafter the "Association") which Declaration was recorded on August 18, 2007 as Document No. 0716903044 in the office of the Recorder of Deeds of Cook County Illinois and covers the property (hereafter the "Froperty") legally described In Exhibit "A" which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article II Section 3.20 of the aforesaid Declaration and Section 26 of the Illinois Condominium Property Act ("the Act"). The Declaration provides that an Owner of a Unit may assign, to another Owner of a Unit, the Storage Space (limited common elements) appurtenant to the Unit Ownership suggest to the prior written consent of the holder of a first mortgage upon the Unit Ownership, upon the recorded of an amendment to the Declaration in accordance with Section 26 of the Act. Section 26 of the Act provides that each transfer of limited common elements shall be made by an amendment to the Declaration executed by all unit owners who are parties to the transfer and consented to by all other unit owners who have any right to use the limited common elements affected. Section 26 further provides that amendment shall contain a certificate showing that a copy of the amendment has been delivered to the Board of Managers of the Association, and shall contain a statement from the parties involved in the transfer which sets forth any change in the parties' proportionate shares of the common elements. No transfer shall become effective until the amendment has been recorded in the Officer of the Recorder of Deeds of Cook County, Illinois.

- 2. Except to the extent expressly set forth lereinabove the remaining provisions of the Declaration shall continue in effect without change.
