This document is recorded for the purpose of amending the Declaration of Covenants, Conditions, Easements and Restrictions for the Townhomes of Alpine Heights Homeowners Association (hereafter the "Declaration") for The Townhomes of Alpine Heights Homeowners Association (hereafter the "Association"), which Declaration was recorded on October 7, 1994 as Document Number 94870643 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit A, which is attached hereto and made a part hereof.

WITNESSETH:

WHEREAS, the Association is the assignee of the developer's rights as set forth and described in the Declaration; and

WHEREAS, pursuant to Paragraph 11.05 of Article Eleven of the Declaration, the Declaration may be amended by an instrument in writing setting forth such amendment, signed and acknowledged by the voting members having at least 51% of the total votes of the members or that is approved at a duly called and held a general or special meeting of the members by the affirmative vote, either in person or by proxy, of the voting members having a majority of the total votes of the members and containing a certification by an officer of the association that said instrument was duly approved as aforesaid; and

WHEREAS, This Amendment has been signed and acknowledged by the voting members having at least 51% of the total votes of the members were approved at a duly called and held general or special meeting of the members by the affirmative vote, either in person or by proxy, of the voting members having a majority of the total votes of the members as set forth in the certification attached hereto as Exhibit B ; and

WHEREAS, the effective date of the Amendment shall be the date of recordation.

NOW, THEREFORE, the Association hereby declares Section 16 of Article V of the Declaration is deleted and replaced with the following:

Article Four is modified as follows (additions indicated by underline deletions by ~~strikethrough~~):

MAINTENANCE BY ASSOCIATION AND OWNERS .

4.01 Association's Obligations. In addition to the rights, powers and duties of the Association under applicable law or as otherwise set forth in this Declaration and in the By-Laws of the Association, the Association shall have the following rights, powers and duties with regard to the Common Area, individual dwellings and lots, the cost and expense of which shall be paid for by the Association from the assessment fund.

(a) Common Area. The Association shall repair, replace and maintain the common area (if any) and all facilities, improvements and equipment thereon and pay for all expenses and services in connection therewith, including without limiting the generality of the foregoing: snow removal, lighting of the street lights, stormwater management facilities, comprehensive liability, hazard and other insurance, payment of all taxes, assessments and other liens and encumbrances which are assessed to or charged against the Common Area or other property owned by the Association, and such other services for the common area as the Board deems to be in the best interest of the Association and its members. The Association shall also be responsible for snow removal on all sidewalks and driveways, maintenance and repair of all streets sidewalks (on Orange), retention walls and fencing, the locks on the individual mailboxes, stormwater management and the well, landscape sprinkler system and utilities that are not the responsibility of the provider of the utilities.

(b) Dwelling Units and Lots. The Association shall maintain, repair, and replace portions of the dwelling units and lots as follows: Landscaping & shrubs (maintenance only, no replacement) wood decks/fencing (staining only), concrete driveways/patios (seal coating only), roof/siding/brick/gutters (repair/replace for normal wear & tear only).

4.02 Owner's Obligations. Except for that which the Association is to provide or is liable for pursuant to Paragraph 4.01 (a), each Owner, at his sole cost and expense, shall maintain, repair and replace his dwelling and Lot and the improvements thereon, keeping the same ~~slightly~~ sightly and in good condition and repair, including, without limitation, exterior surface of the dwelling, roofs (due to casualty loss), siding, shrubs and other landscaping (replacement only) window washing and repair, watering of all landscaping, and any solar energy equipment which may be installed on the roof of his dwelling or elsewhere on his Lot. In the event any Owner shall fail to do so, the Association, in addition to all other remedies available to it hereunder or by law, and without waiving any of said alternate remedies, shall have the right (but not the obligation), through its employees and agents or through independent contractors, upon reasonable notice or, in the case of an emergency, without notice, to enter upon any Lot and, if required into any dwelling, to repair and maintain the Lot and the improvements situated thereon. Each Owner, by acceptance of a deed to his Lot, hereby covenants and agrees to pay the Association the cost of such repairs and maintenance, upon demand, and the Association shall have a lien upon said Lot enforceable in the manner of Assessments as provided in Article 5. The failure of such Owner to pay such costs shall carry with it the same consequences as the failure to pay any assessments levied hereunder when due, as herein provided. The Association shall be responsible for and shall repair any damage caused by it in the exercise of its rights hereunder.

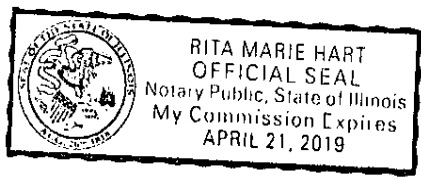
This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
