MEMORANDUM OF LONG-TERM OPERATING SUBSIDY AGREEMENT

THIS MEMORANDUM OF LONG-TERM OPERATING SUBSIDY AGREEMENT, dated as of the 25th day of March, 2019, is entered into by and between CICERO SENIOR LOFTS, LLC, an Illinois limited liability company (the "Owner"), and the CHICAGO LOW-INCOME HOUSING TRUST FUND, an Illinois not-for-profit corporation (the "Trust Fund").

WITNESSETH:

WHEREAS, the Trust Fun I and the Owner have entered into that certain Long-Term Operating Subsidy Agreement dated as of Marc' 125, 2019 (the "LTOS Agreement") and that certain Escrow Agreement dated as of March 25, 2019 (the "Escrow Agreement"), which is appended to the LTOS Agreement as Exhibit M; the Escrow Agreement, together with the LTOS Agreement, collectively are the "Agreement"), pursuant to which the Trust Fund has a greed to provide certain rental subsidy payments to the Owner to be used with respect to that certain property described on Exhibit A hereto (the "Property") and in accordance with the terms, conditions and coverage as set forth therein; and

WHEREAS, the Trust Fund and the Owner desire to $\rho^1 ac$: of record the existence of the Agreement together with certain of its terms.

NOW THEREFORE, in consideration of the premises and the mutual covenants made and obligations undertaken by the Trust Fund and Owner in the Agreement, the parties hereto agree as follows:

- 1. All of the terms, provisions, covenants and agreements between the Trust Fund and the Owner are set forth in the Agreement. Four (4) studio units at the Property must be leased to tenants earning incomes at or below 30% of the area median income ("AMI") and four (4) studio units at the Property must be leased to tenants earning incomes at or below 15% AMI (the "Use Restriction").
- 2. Except as otherwise permitted in the Agreement, the Owner is prohibited from the sale. Transfer or conveyance of the Property or any other transfer of ownership interests affecting the Property or the Agreement without the prior written consent of the Trust Fund ("Sale Restriction").
- 3. Unless the Agreement is terminated or otherwise expires earlier, in accordance with the terms of the Agreement, the Use Restriction, Sale Restriction and all other obligations set forth in the Agreement shall remain in effect until June 30, 2041.
 - 4. As of the date hereof, the Agreement is in full force and effect.
