- 2. Owner, either on its own, or by and through someone acting as an agent, tenant or entity otherwise knowingly authorized to enter into contracts on behalf of Owner for improvements to the Property, entered into a contract with Contractor for the replacement of glass, framing and other glass or glazing work located on the Property (the "Project").
- 3. Shortly thereafter, Contractor entered into a written subcontract, dated February 26, 2018, with Claimant for Claimant to furnish the labor and materials for the installation of curtainwall glass, mirrored glass, glass and aluminum doors, framing, hardware and other related glass or glazing services for the Project (the "Subcontract"). The original Subcontract sum for all of these services was Two Million Twenty-Five Thousand Dollars (\$2,025,000.00).
- 4. Claimant was directed to perform additional and extra services that have been memorialized in written change orders in the amount of Four Hundred Thirty-Two Thousand Nine Hundred Thirty-Six Dollars and Sixty-One Cents (\$432,936.61) raising the total Subcontract Price to Two Million Four Hundred Fifty-Seven Thousand Nine Hundred Thirty-Six Dollars and Sixty-One Cents (\$2,457,936.61).
- 5. Claimant furnished the labor and materials required by the Subcontract, which were all incorporated into or used in the improvement of the Property. Claimant substantially completed furnishing its labor and materials on December 27, 2018.
- 6. After allowing all due credits, there is unpaid, due and owing to Claimant the sum of Two Hundred Fifty-Seven Thousand Four Hundred Fifty-One Dollars and Sixty-One Cents (\$257,451.61), for which, with interest, the Chimant claims a lien on the Property and improvements, and on the monies or other considerations due or to become due to Contractor from the Owner, an agent of the Owner, or one knowingly authorized by the Owner.
- 7. On information and belief, the Owner had knowledge of and consented to Claimant's furnishing of the labor, materials, and equipment for said work and in the improvement of the Property.
