The Contract hired Claimant to provide all necessary material, labor and equipment to repair the water damaged Real Estate described above, including demolition, removal, and disposal of damaged materials and structures, pack-out of property contents necessary permit repairs, structural cleaning, structural repairs including cabinets, doors, windows and trim, drywall, electrical fixures, carpeting, vinyl tile, flooring, finish carpentry, and HVAC, along with painting. Following August 28, 2018 and through no later than the date of January 10, 2019, Claimant diligently worked to perform the work and supply the materials and equipment required under the Contract. On January 10, 2019, Claimant completed all work required to be performed on the Real Estate pursuant to the Contract. Despite Claimant's completion of the work required on the Contract, Claimant has receive lonly partial payment for its work, and Owner is entitled to credits for payment of \$46,285.02. As of the of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of THIRTY THOUSAND TWO HUNDRED TWENTY-TWO and 11/100 DOLLARS (\$30,222.11.), which sum bears interest at the contractual rate of 1.5% per month. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$30,222.11, plus interest and attorneys' fees as provided by the Contract.
