SECOND AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF CONDOMINIUM OWNERSHIP FOR 3600 CONDOMINIUM ASSOCIATION

This document is recorded for the purpose of amending the Amended and Restated Declaration of Condominium Ownership (hereafter the "Declaration") for 3600 Condominium Association (hereafter the 'Association"), which Declaration was recorded on December 22, 2016, as Document No. 1635734028 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "1", which is attached hereto and made a part thereof.

The amendment to the Declaration is adopted pursuant to the provisions of Paragraph 22 of the aforesaid Declaration and Section 17 and Section 18.8(e) of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), and signed by Unit Owners owning not less than two-thirds (2/3) of the total ownership of the Common Elements, and provided further that it contains an affidavit by the Secretary of the Board, certifying that a copy of the change has been sent by certified mail to all lien holders of record against any Unit.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Owners desire to amend Paragraph 19 of the Declaration; and

WHEREAS, the amendment to the Declaration has been executed by the President of the Association or such other officer authorized by the Board, and signed by Unit Owners owning not less than two-thirds (2/3) of the total ownership of the Common Elements, and due notice having been provided to all lien holders of record against any Unit, all in compliance with Paragraph 22 of the Declaration and Section 17 and Section 18.8(e) of the Act.

NOW THEREFORE, Paragraph 19 of the Amended and Restated Declaration of Condominium Ownership for 3600 Condominium Association is hereby amended in accordance with the text which fellows (additions in text are indicated by <u>double underline</u>; deletions by <u>strike outs</u>):

- "(H) No Unit Owner who closes the acquisition of a Unit after the date this amendment is recorded may lease a Unit unless such Unit Owner has owned the Unit for at least two (2) years.
- (I) No Unit permitted to be leased shall be used for hotel or transient purposes or subleased, which is defined as a lease or other occupancy of a Unit of less than twelve (12) months."

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration and By-Laws shall continue in effect without change.
