#### DETAILED EXPLANATION OF ERROR AND WHAT THE CORRECTION IS:

The conveyance paragraph of the Quit Claim Deed improperly recited the Grantee's Trust name as a typographical error. The Grantee was listed as ANN E. HARRISON AND JAMES K. HARRISON, OR THEIR SUCCESSOR IN INTEREST, AS TRUSTEES OF THE ANN E. HARRISON 2019 TRUST, U/T/A DATED MARCH 1 2019. The proper Trust name of the Grantee is as follows: ANN E. HARRISON AND JAMES K. HARRISON, OR THEIR SUCCESSOR IN INTEREST, AS TRUSTEES OF THE ANN E. HARRISON LIVING TRUST, DATED MAY 26, 2004.

#### RIDER
