MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated May 1, 2019, is made and executed between Edison Park Chamber of Commerce, whose address is 6730 N OLMSTED AVE, CHICAGO, IL 60631 (referred to below as "Grantor") and FIRST NATIONS BANK, whose address is 7757 W. 

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



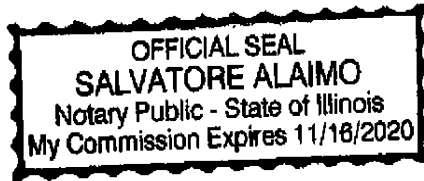
