IT IS HEREBY ORDERED:

That a Judgment for attorneys' fees is entered in favor of JOHN F. MARTOCCIO and MARTOCCIO & MARTOCCIO and against JAMES DREW CURRAN in the amount of \$174,000 as of August 22, 2018.

JAMES DREW CURRAN shall be entitled to a 10% discount on the Judgment of \$174,000, and an additional \$1,700 discount should be comply with the following conditions:

- That JAMES DREW CURRAN shall pay the sum of \$100,000 to MARTOCCIO & MARTOCCIO & MARTOCCIO & MARTOCCIO & MARTOCCIO & CURRAN pursuant to Paragraph K of the parties' Judgment for Dissolution of Marriage entered on August 1, 2018.
