AN ORDINANCE DISSOLVING SPECIAL SERVICE AREA NO. 4

Whereas, on December 18, 2007, the City Council adopted Ordinance No. 07-62 entitled "An Ordinance Establishing Special Service Area No. 4" within the area legally described on the attached Exhibit "A";

Whereas, the City levied a Special Service Area tax for the year 2007;

Whereas, the City Council has not levied any Special Service Area Taxes since 2007; and

Whereas, the City Council has determined that it is in the best interests of the City to repeal Ordinance No. 07-62 without prejudice to the Special Service Area's 2007 Special Service Area tax.

Now Therefore, Be It Ordained by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section Two: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows, Illinois.


Section Three: This Ordinance shall be in full force and effect from and after its passage, and approval in the manner provided by law.


