Plaintiff, THE CITY OF CHICAGO ("the City"), by and through its attorney, Edward Siskel, Corporation Counsel, and the undersigned attorney, complains of the defendants as follows:

COUNT I

Within the corporate limits of Chicago, there is a parcel of real estate legally described as:
