AFFIDAVIT

Mary Brosnan, being first duly sworn on oath, states and avers as follows:

1. That Michael P. Brosnan died in Chicago, Illinois, on July 21, 1998, at the age of 66.
2. The Estate of Michael P. Brosnan was administered in the Circuit Court of Cook County, Illinois, as case number 98 P 6947 (the "Probate Estate"). Such Probate Estate was opened on August 26, 1998 and discharged on August 25, 1999.
3. I am of legal age. I reside at 6320 W. 110th Street, Chicago Ridge, IL 60415, Illinois. I am related to the decedent, being the decedent's sister. I have full knowledge of the facts relating the heirship of the decedent and I am of legal age and of no disability.
4. The decedent was never married.

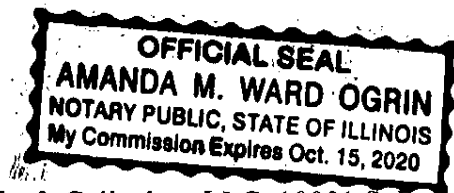
