That on or about February 21, 2019, the Claimant made a contract with the Owner to provide material, labor and equipment to repair the water damaged Real Estate described above, including demolition, removal, and disposal of damaged structures and materials, water extraction, commercial dehumidification, manipulation of property contents necessary to permit repairs, and additional structural repairs including cabinetry, dryvell, floor coverings, insulation, framing and rough carpentry, painting, finish carpentry, and plumbing. Following February 21, 2019 and through the date of April 10, 2019, Claimant diligently worked to perform the work and supply the materials and conjument required under the Contract. On April 10, 2019, Claimant completed all work required to be performed on the Real Estate pursuant to the Contract, in a total amount of \$38,317.80. Despite Claimant's completion of the work on the Real Estate required on the Contract, Claimant has received only partial payment for its work, and Owner is entitled to crecits for payment of \$14,145.55. As of the of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of TWENTY-FOUR THOUSAND ONE HUNDRED SEVENTY-TWO and 25/100 DOLLARS (\$24,172.25), which sum bears interest at the contractual rate of 1.5% per month. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$24,172.25, plus interest and attorneys' fees as provided by the Contract.
