("Owner"); GEMCHI (IL), LLC ("Owner"); GEMS CHICAGO, (NC. d/b/a GEMS WORLD ACADEMY CHICAGO ("Tenant"); POWER CONSTRUCTION COMPANY, LLC ("General Contractor"); CECCHIN PLUMBING & HEATING, INC. ("Subcontractor") and ALL UNKNOWN OWNERS AND NON-RECORD **CLAIMANTS**, and any person or entity claiming an interest in the Property (as hereinafter defined) by, through, or under Owner, Tenan', General Contractor, and Subcontractor, and states:

That at all relevant times, the Owner owned the following described Land in the City of Chicago, County of Cook, State of Illinois, and legally described as follows:

Upon information and belief, on or before November, 2018, GEMS AMERICA, INC. and/or GEMCHI (IL), LLC, as Owner, authorized or knowingly permitted GEMS CHICAGO, INC. d/b/a GEMS WORLD ACADEMY CHICAGO, as Tenant, to enter into a certain construction agreement (the "General Contract") with POWER CONSTRUCTION COMPANY, LLC, as General Contractor, whereby General Contractor agreed to provide certain labor, material and work at the Property (the "Project"), the exact terms and conditions of said General Contract are unknown to Claimant, the same being in the exclusive knowledge and possession of the parties thereto.

Upon information and belief, in or before November, 2018, General Contractor, being then engaged in the construction of said Project and for the purpose of carrying out and performing the terms of its General Contract with the Owner and/or Tenant, engaged the services of CECCHIN PLUMBING & HEA GNG, INC., as Subcontractor, whereby Subcontractor agreed to provide certain labor, material and work at the Project, the exact terms and conditions of said engagement are unknown to Claimant, the same being in the exclusive knowledge and possession of the parties thereto.

That on or about November 1, 2018, Subcontractor, being then engaged in the construction of said Project and for the purpose of carrying out and performing the terms of its engagement with the General Contractor, entered into a purchase order with Claimant, whereby Claimant was to furnish certain labor, equipment and materials to install the insulation and firestop system at the Project for the sum of *One Hundred Ninety-One Thousand Four Hundred Forty-Eight Dollars* (\$191,448.00).

Pursuant to the special instance and request of the Owner and/or Tenant and/or General Contractor and/or Subcontractor, Claimant was engaged to provide certain extra labor, materials, tools and equipment to the Project in the amount of *One Thousand Four Hundred Ninety-Eight 96/100 Dollars (\$1,498.96)*, thereby resulting in an adjusted contract price of *One Hundred Ninety-Two Thousand Nine Hundred Forty-Six 96/100 Dollars (\$192,946.96)*.

Pursuant thereto, Claimant furnished and delivered certain labor, materials, tools and equipment to the Owner, Tenant, General Contractor and Subcontractor at the P:cject in the total amount of One Hundred Thirty-Seven Thousand Three Hundred Eighty-Nive and 96/100 (\$137,389.96), all of which was used in the above Project.

The last day Claimant supplied the work, labor and materials to the Project was May 10, 2019, at which time Claimant ceased work at the Project due to Subcontractor's failure to pay for amounts due and owing.

That as of the date hereof, Owner, Tenant, General Contractor and Subcontractor are entitled to credits and payments in the amount of *Twenty-Two Thousand Seven Hundred Thirty-Two and* 96/100 (\$22,732.96), leaving due and owing to Claimant the sum of *One Hundred Fourteen Thousand Six Hundred Fifty-Seven Dollars* (\$114,657.00), for which, with interest, the Claimant claims a lien on said Property, Project and improvements thereon and on the monies, bonds and/or warrants or other considerations due or to become due from Owner and/or Tenant to the General

Contractor under said General Contract and from the General Contractor to Subcontractor pursuant to its engagement with the Subcontractor, as well as court costs and legal fees pursuant to *Illinois Compiled Statutes*, Chapter 770, Section 60/17.
